The ARPA funds provided a unique opportunity for state and local governments to make strategic investments in long-lived assets, rebuild reserves to enhance financial stability, and cover temporary operating shortfalls until economic conditions and operations normalize. However, these funds shall be exhausted in 2022. ACHRM's eleven healthcare cost containment strategies provide savings opportunities for businesses and organizations beyond the ARPA funds.
- → Eight new sponsor partners have joined ACHRM in 2022 strengthening and expanding our HCCs and solutions. We have a series of special projects to engage these sponsor partners upon building on our current public entities special projects.
- → In 2022, ACHRM is planning many virtual events, averaging 30 attendees per event and more of those attendees as new professionals to our ACHRM community!


